

3. Engage auditor to conduct audit for fiscal year end May 31, 2025.
4. Discuss Security Report.
5. Discuss constable building partnership with Cypress Hill Municipal Utility District No. 1 and authorize appropriate action, if necessary.
6. Financial and bookkeeping matters, including payment of bills and review of investments.
7. Adopt budget for fiscal year end May 31, 2026.
8. Travel Reimbursement Guidelines and Director Expenses for the Association of Water Board Directors summer conference.
